Introduction

The following issues have been identified are present in the annual data:

Developing dataset

The outpatient dataset is a developing dataset which has a number of continuing issues regarding quality and coverage of certain key fields.

Operation codes

Due to a technical error operation codes 2 and upwards have not been cleaned.

Impact: invalid codes may be present in operation code 2 and upwards – they will not have been cleaned away to '&'. This is a display issue only since all valid codes are still present and decoded. Invalid codes will have a description and values that are identical.

Extract date not consistent across all providers

The following organisations have had gaps in their data resolved by using data contained within earlier HES extracts.

Genito-urinary medicine (GUM) clinic data

The number of trusts supplying Genito-urinary medicine (GUM) clinic data is still very low for HES. Out of approximately 400 trusts submitting attendance data, only 14 submitted GUM data in 2005-06. This has gradually improved over the years with 18 trusts submitting GUM data in 2006-07 and 19 trusts in 2007-08. Thus the data is presented in the spirit of transparency and in order to encourage improvements, but caution must be urged in its use. Failure to release this data could slow down the quality improvement process. This would reduce the usefulness of subsequently collected data in monitoring the 18 weeks wait target.
